 - b. Pastor Dirk van der Duim resigned in good standing from the roster of the NEOS.

- c. She will be traveling to El Paso, TX to participate in a Boarder Immersion Experience representing Region 6. A grant from Boarder Servant Corp. will pay half of the cost.
- d. The first meeting of quarterly gatherings of Judicatory Heads was held at the Lutheran Center on January 11, 2024.

- 13. The Synod's estimated year-to-date loss is -\$211,313.

The goal of these discussions will be to continue Lutheran Men in Missions: To help men gain a stronger relationship with the church and become like Jesus in faith and mission to serve others.

Received the report of Mr. Neville Reid, a partner in the firm of Fox, Swibel, Levin & Carroll, LLP, that summarized his audit of the ELCA's governing documents for diversity, equity, inclusion, and accessibility. The report has been referred to the Legal and Constitutional Review Committee and the Commission for a Renewed Lutheran Church. It is anticipated that recommendations for changes to the Churchwide governing documents will be introduced at the 2025 Churchwide Assembly resulting from the audit.
